"17-3-211. Forest reserve money. The state treasurer,  
for the purpose of carrying out the provisions of an act of  
congress of May 23, 1908, 35 United States Statutes at  
Large, p. 260, and all acts subsequent thereto, shall divide  
and distribute all forest reserve moneys received by the  
state thereunder to and among the several counties entitled  
thereto and pay the same to the several county treasurers of  
such counties within 30 days after receiving full payment of  
the same, as directed by the state auditor."
