DESCRIPTION OF PROPOSED LEGISLATION:

House Bill 320 revises the method by which the Department of Highways disposes of real property; raises the value of real property that can by sold at private sale; allows the sale to units of local government; provides method of sale; and removes successor-in-interest provision.

ASSUMPTIONS:

- 1) Sales by public bid (method of sales under current law) generate 102% of appraised value. [Based on last two years' sales.]
- 2) Sales by sealed bid generate 133% of appraised value.
- 3) 20 tracts with an average value of \$400 will be sold each year at private sale under the proposed law without the advertising and bid requirements. These sales would not be made under current law, since costs would exceed value of parcel.
- 4) Savings per sale will be \$322, due to reduced advertising and travel.
- 5) The appraised value of land offered by public sale will be \$245,000.
