BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Appropriation. (1) There is appropriated \$66,078.69, or so much thereof as may be necessary, from the general fund to the Department of Revenue to satisfy the judgment of the District Court in the case of The Conrad National Bank of Kalispell v. The Department of Revenue, Civil Cause No. 29,099, County of Flathead.

(2) The appropriation provided in subsection (1) is an amount to pay the judgment of \$53,764.41 and interest thereon at a rate of 10%, as ordered by the court, calculated to June 30, 1983. If the judgment is paid by the Department of Revenue prior to that date, excess portions of the appropriation shall revert to the general fund.

Section 2. Appropriation nonjudgmental. By appropriating the above sums, the Legislature is not passing judgment on the merits of the case for which the appropriation is made.

Section 3. Effective date. This act is effective on passage and approval.
