BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Membership in associations of county
assessors. (1) A county assessor may obtain county
membership in and cooperate with associations of Montana
county assessors formed for the furtherance of good
government and the protection of county interests.
Membership costs must be borne by the county as approved by
the board of county commissioners.

(2) The county assessor in each county is entitled to
reimbursement by the county for actual travel expenses and
per diem allowances for expenses incurred in connection with
attendance at the annual meeting of an association of county
assessors. The proportionate costs of the association
attributable to each county as an association member must be
paid by the county.

In compliance with a written request received February 2, 19 83, there is hereby submitted a Fiscal Note for House Bill 579 pursuant to Chapter 53, Laws of Montana, 1965 - Thirty-Ninth Legislative Assembly. Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

DESCRIPTION OF PROPOSED LEGISLATION:

House Bill 579 authorizes county assessor membership in county assessor associations and to provide for county payment of associated costs.


FISCAL IMPACT:

No fiscal impact upon state government.

EFFECT ON COUNTY OR OTHER LOCAL REVENUE OR EXPENDITURES:

County Assessor Association membership fees are \$400 for first and second class counties; \$300 for third, fourth and fifth class counties; and \$200 for sixth and seventh class counties. The average cost of reimbursement for the association's annual convention is \$280, assuming per diem, lodging and mileage are the same as those allowed state officials.
