## DESCRIPTION OF PROPOSED LEGISLATION:

House Bill 627, amended, amends Section 2-18-104, MCA, to increase from 5 to 10 the number of members of the Public Service Commission personal staff that are exempt from certain provisions of the state employee classification and pay plan.

### COMMENT:

The amendments do not change the fiscal impact of the original fiscal note. Refer to that for assumptions and costs.
