(1) Except as provided in this chapter, if there is a 13 14 noncompliance by the tenant with the rental agreement or a 15 noncompliance with 70-24-321 affecting health and safety, the landlord may deliver a written notice to the tenant 16 17 pursuant to 70-24-108 specifying the acts and omissions constituting the breach and that the rental agreement will 18 terminate upon a date not less than 14 days after receipt of 19 the notice.
