In compliance with a written request received January 20, 19 83, there is hereby submitted a Fiscal Note for Senate Bill 205 pursuant to Title 5, Chapter 4, Part 2 of the Montana Code Annotated (MCA). Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

DESCRIPTION OF THE PROPOSED LEGISLATION:

Senate Bill 205 extends the "Employee Incentive Program" for two more years.


ASSUMPTION:

- 1) 0.35 general fund FTE is assigned to the program and absorbed.
- 2) Agency personal service costs are widely dispersed, absorbed and undetermined.
- 3) In each fiscal year, there will be at least one successful suggestion resulting in a first year cost-savings of at least \$25,000.
- 4) Promotional and printing costs will equal \$700 in each of the next two fiscal years.
