In compliance with a written request received <u>January 11</u> Fiscal Note for <u>H.B. 108</u> pursuant to Title 5, Chapter 4, Part 2 of the Montana Code Annotated (MCA). Background information used in developing this Fiscal Note is available from the Office of Budget and Program Planning, to members of the Legislature upon request.

DESCRIPTION OF PROPOSED LEGISLATION:

House Bill 108 changes the amount paid to a county by the United States and the Department of Justice, Highway Patrol Division for holding a prisoner in a county jail.

ASSUMPTIONS:

- 1. In FY 1984 \$49,684 was paid by the Department of Justice, Highway Patrol Division, to various counties for holding of prisoners.
- 2. Each county will bill the Department of Justice, Highway Patrol Division, the maximum allowed under the proposed legislation.
- 3. There will be no increase 'or decrease in the number of prisoner/days over the base year used; fiscal year 1984.

LOCAL IMPACT:

Counties would realize approximately \$99,368 additional revenue from the State of Montana and an indeterminate amount from the federal government to support the costs of prisoner incarceration.
