(b) the location of the claim or claims by section,
township, and range, by projected survey lines if located in
unsurveyed country;

(c) the book and page numbers wherein the original or
 latest amended relocation for each claim is recorded;

3 (d) the number of days' work done and the character
4 and value of the improvements placed thereon or the verified

8 (e) the dates between which such work or improvements

(2) Annual assessment work may be performed or caused 14 15 to be performed at one or more points within a group of 16 contiguous claims and may be utilized to satisfy annual assessment work requirements upon the group of contiguous 17 claims. Said point or points of work may be performed upon 18 a patented claim. If annual assessment work is performed or 19 caused to be performed at one or more points within a group 20 21 of contiguous claims, the affidavit of performance of assessment work must be filed for the group of claims. The 22 affidavit, in addition to requirements established by this 23 24 section for affidavits of performance of assessment work. 25 must contain a description and location of the work done

upon the group at a point or points within the group, the
 specific names of all the claims in the group for whose
 benefit the work was performed, and the total cost of the
 work performed.

5 (3) If group work is claimed for a group of claims 6 crossing county lines, the affidavit required by this 7 section shall be filed for recording within the required 8 time in each of the counties in which such claims are 9 located.

(4) An affidavit of performance of annual assessment 10 work must be verified before some officer authorized to 11 12 administer oaths by the locator or one of the locators, if there be more than one, or by authorized agent. In the case 13 of a corporation, the verification may be made by any 14 officer thereof or by an authorized agent. When the 15 verification is made by an agent, the fact of the agency 16 17 shall be stated in the affidavit. Such affidavit or a certified copy thereof is prima facie evidence of the facts 18 therein stated. The failure to file such affidavits within 19 the period allowed therefor shall be prima facie evidence 20 that such labor has not been performed and that the owner of 21 the claim or claims has abandoned and surrendered same. 22
