HOUSE BILL NO. 273 INTRODUCED BY Pistoria

A BILL FOR AN ACT ENTITLED: "AN ACT TO PROHIBIT OPERATION 4 OF A FOOD VENDING MACHINE THAT IS ALSO USED FOR THE PURPOSE 5 OF DISPENSING OR SELLING CIGARETTES; AMENDING SECTIONS 50-50-102 AND 50-50-201, MCA." 7

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA: 9 Section 1. Section 50-50-102, MCA, is amended to read: 10 "50-50-102. Definitions. Unless the context requires 11 otherwise, in this chapter the following definitions apply: 12 means the board of health and (1) "Board" 13 environmental sciences, provided for in 2-15-2104. 14

(2) "Department" means the department of health and 15 environmental sciences, provided for in Title 2, chapter 15, 16 part 21. 17

means a food manufacturing (3) "Establishment" 18 establishment, meat market, food service establishment, 19 frozen food plant, commercial food processor, or perishable 20 food dealer. 21

(4) "Food" means an edible substance, beverage, or 22 ingredient used, intended for use, or for sale for human 23 24 consumption.

(5) "Food manufacturing establishment" means a 25

1 commercial establishment and buildings or structures in connection with it used to manufacture or prepare food for 2 sale or human consumption, but does not include milk 3 producers' facilities, milk pasteurization facilities, milk 4 product manufacturing plants, slaughterhouses, or meat 5 6 packing plants.

7 (6) "Food service establishment" means a fixed or 8 mobile restaurant, coffee shop, cafeteria, short-order cafe, 9 luncheonette, grille, tearoom, sandwich shop, soda fountain, food store serving food or beverage samples, food or drink 10 vending machine, tavern, bar, cocktail lounge, nightclub, 11 feeding establishment, catering kitchen, 12 industrial commissary, private organization routinely serving the 13 public, or similar place where food or drink is prepared, 14 15 served, or provided to the public with or without charge. 16 The term does not include establishments, vendors, or vending machines which sell or serve only packaged 17 nonperishable foods in their unbroken original containers or 18 a private organization serving food only to its members. 19

(7) "Frozen food plant" means a place used to freeze. 20 process, or store food including facilities used in 21 22 conjunction with the frozen food plant and a place where individual compartments are offered to the public on a 23 24 rental or other basis.

(8) "Meat market" means a commercial establishment and

buildings or structures in connection with it used to
 process, store, or display meat or meat products for sale to
 the public or for human consumption.

4 (9) "Perishable food dealer" means a person or 5 commercial establishment which is in the business of 6 purchasing and selling perishable food to the public.

(10) "Person" means a person, partnership, corporation,
association, cooperative group, or other entity engaged in
operating, owning, or offering services of an establishment.
(11) "Vending machine" means any device offered for
public use that upon insertion of a coin, coins, or tokens,
or by other means, dispenses foodstuffs, beverages, and
other food products."

14 Section 2. Section 50-50-201, MCA, is amended to read: 15 "50-50-201. License required. (1) A person operating 16 an establishment shall procure an annual license from the 17 department.

(2) A separate license is required for each
establishment, but if more than one type of establishment is
operated on the same premises and under the same management,
only one license is required.

(3) Only one license is required for a person owning
and operating one or more vending machines. <u>The department</u>
<u>shall deny or revoke a license to operate any vending</u>
<u>machine used for the purpose of dispensing or selling both</u>

1 food products and cigarettes as defined in 16-11-102.

2 (4) Before a license may be issued by the department
3 it must be validated by the local health officer, or if
4 there is no local health officer the samitarian, in the
5 county where the establishment is located."
