INTRODUCED BY Carminer 14 1 2 3 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING THE 4 LAWS RELATING TO THE ELECTION AND TERMS OF IRRIGATION 5 DISTRICT COMMISSIONERS AND DRAINAGE DISTRICT COMMISSIONERS; 6 AMENDING SECTIONS 85-7-203, 85-7-1501, 85-7-1702, 85-8-301, 7 85-8-302, AND 85-8-304, MCA." 8 9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA: 10 Section 1. Section 85-7-203, MCA, is amended to read: 11 "85-7-203. Petition, hearing, and order. Whenever the 12 owners of land and water rights, as described in 85-7-202. 13 desire to organize for the purposes mentioned in this part, 14 a petition to that effect, signed by not less than 60% of 15 the individual landowners who represent not less than 51% of 16 the irrigable acres to be affected by the proposed district 17 and 51% of the cubic feet of water per second decreed or 18 adjudicated in the stream from which the irrigation district 19 is to operate, shall be filed with the clerk of the district 20 court of the county or counties in which the district is to 21 be created. For the purpose of determining whether the 22 requirements of acreage and cubic feet of water per second 23 have been met by the petition, water diverted from the 24 and distributed under irrigation 25 adjudicated stream



districts other than the one to be created under this part 1 2 may not be considered; however, such water and acreage shall be required to pay all assessments the same as other water 3 and acreage affected by irrigation districts created under 4 this part. Upon filing of the petition, the court shall set 5 a date for a hearing on the petition and a written notice 6 shall be mailed, not less than 5 days prior to the hearing, 7 to each landowner or water right owner affected by the 8 proposed district. If the court finds from such hearing that 9 10 an irrigation district, as prayed for in the petition, is feasible and practical, the court shall issue an order 11 12 creating the irrigation district. The order shall constitute the authority for the district to function for the purposes 13 and intent as outlined in this part. The court shall appoint 14 15 five commissioners who are landowners or water right owners 16 affected by such district to act until the first annual meeting their successors are elected, gualified, and begin 17 their terms of office." 18 Section 2. Section 85-7-1501, MCA, is amended to read: 19 "85-7-1501. Qualifications of commissioners and term

20 "85-7-1501. Qualifications of commissioners and term 21 of office. (1) No person may be a commissioner unless he is 22 an owner of land within the district and is a resident of 23 the county in which the division of the district or some 24 portion thereof, for which the commissioner is elected, is 25 situated.

(2) The commissioners appointed shall hold their 1 respective offices until the--second-Saturday-in-Becember 2 following--their--appointment--and--until their respective 3 successors are elected, and qualified, and begin their terms 4 of office. Each of the commissioners shall qualify in the 5 same manner as justices of the peace. The bond for a 6 commissioner shall be approved by the district court or 7 judge thereof and filed in the office of the clerk of the 8 court." 9

Section 3. Section 85-7-1702, MCA, is amended to read: 10 "85-7-1702. Regular election -- procedure -- results 11 -- term of office. (1) Candidates for the office of 12 commissioner may be nominated by petition filed with the 13 election administrator or deputy election administrator at 14 least 30 days before the election and signed by at least 15 five electors of the district. If no nominations are made, 16 the electors of the district shall write on the ballots the 17 name or names of the persons for whom they desire to vote. 18 (2) The regular election for commissioners in each 19 district shall be held annually in-accordance-with--13-1-104 20 and-13-1-401 on the first Monday in May. The term of office 21 of a commissioner is 3 years or until his successor is 22 elected and qualified. The term begins on the first Monday 23 of July following the election. 24

6 (4)(6) Commissioners are elected by the electors of 7 the entire district."

Section 4. Section 85-8-301, MCA, is amended to read: 8 "85-8-301. Term of commissioners at creation of 9 10 district. On the creation of a district the commissioners appointed by the judge or court shall hold office until the 11 12 first-Tuesday-in-May-following-their-appointment--and--until 13 their successors are elected, qualified, and begin their terms of office. When a district is in existence on March 1, 14 1921, and thereafter an order is made dividing such district 15 into divisions, the terms of office of such commissioners 16 17 shall cease with on the first Monday immediately-preceding 18 of July the-first-fuesday-in-May-next--following after the 19 next election following the division order."

20 Section 5. Section 85-8-302, MCA, is amended to read: 21 "85-8-302. Election of commissioners <u>-- procedure</u> --22 regular term of office. (1) The regular election of 23 commissioners shall be held annually <u>in--accordance--with</u> 24 <u>i3-1-104--and--i3-1-401 on the first Monday in May</u>. The term 25 of office of commissioners shall commence on the first

Tuesday -- in -- May Monday in July following their election. At 1 the first regular election following the organization of a 2 district and in districts organized and in existence on 3 March 1, 1921, and which, on petition, have been divided 4 into divisions, at the first regular election following the 5 date of the order making such division, there shall be elected three commissioners, one commissioner being elected 7 from each division of which he must be an actual landowner. 8 One of the commissioners, to be determined by lot, shall 9 hold office until the first Tuesday-in-May Monday in July in 10 the year following his election; another of the 11 commissioners, to be determined by lot, shall hold office 12 until the first Tuesday-in-May Monday in July in the second 13 year following his election; and the third of the 14 commissioners shall hold office until the first Puesday--in 15 May Monday in July in the third year following his election. lñ Thereafter one commissioner shall be elected each year, who 17 shall hold office for a term of 3 years and until his 18 successor is elected and qualified. The secretary of the 12 board of commissioners shall enter the result of the 13 election in the minutes of the board and file with the clerk of the district court creating the district and with the 14 election administrator of the county in which the greatest 15 portion of land in the district is located a statement 16 17 showing the names name of the persons person elected as commissioners commissioner, the name 18 names of the 19 commissioners commissioner whose term will expire on the 20 first Tuesday-in-May Monday in July following the election, and the names of all of the persons who will compose the 21 board of commissioners for the year next following the first 22 23 Tuesday-in-May Monday in July."

24NEW SECTION.Section 7. Staggered terms for25commissioners. At the first election of commissioners

1 following the organization of a district and in districts 2 organized and in existence on October 1, 1985, at the first 3 election of commissioners following that date, there shall 4 be elected five commissioners. Two of the commissioners, to 5 be determined by lot, shall hold office until the first 6 Monday in July in the year following their election; two of 7 the commissioners, to be determined by lot, shall hold 8 office until the first Monday in July in the second year 9 following their election; and one of the commissioners shall 10 hold office until the first Monday in July in the third year 11 following his election. 12 NEW SECTION. Section 8. Codification instruction. 13 Section 7 is intended to be codified as an integral part of
