This bill would provide optional (instead of mandatory) publication requirements for minutes of and claims ordered paid by boards of county commissioners.

- Current publication costs for counties minutes and claims are estimated to be \$187,500 per year. 1.
- 2. If claims could be summarized, it is estimated that these publication costs would be reduced by 66%. for a local savings of \$125,000.
