4 A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF 5 REPRESENTATIVES OF THE STATE OF MONTANA REQUESTING ADOPTION 6 OF A BUDGET FOR THE 1986-87 BIENNIUM THAT REDUCES THE 7 FUNDING LEVEL FOR STATE GOVERNMENT BY 10 PERCENT FROM THE 8 CURRENT FUNDING LEVEL.

10 WHEREAS, the Legislature holds the sole power to 11 appropriate state funds; and

WHEREAS, the Governor has submitted a 1986-87 biennial
executive budget that proposes a \$72.9 million increase in
appropriations as compared to the current biennium; and

15 WHEREAS, the Governor's proposed budget increase 16 results in a 10% growth in state spending as compared to the 17 1984-85 biennium; and

WHEREAS, this increase in state spending must be borne
by the people of the state, who carry the burden of taxes to
fund the operation of the state government; and

21 WHEREAS, the state of the economy in Montana has forced
22 many of the people of the state into financial distress and
23 hardship; and

24 WHEREAS, the state government continues to grow in size25 with the passing of each year and repeatedly requires

1 greater levels of funding for its operation; and

2 WHEREAS, the people of the state are convinced that
3 state government must exercise greater fiscal responsibility
4 at a time of personal economic and financial adversity.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE
OF REPRESENTATIVES OF THE STATE OF MONTANA:

8 (1) That the Legislature of the State of Montana adopt 9 a budget for the state government for each year of the 10 1986-87 biennium that will result in reducing the funding 11 level for state government by 10% from the current funding 12 level for each agency, department, and office of the 13 Executive, Legislative, and Judicial branches of government;

14 (2) That the President of the Senate and the Speaker 15 of the House of Representatives refer the budgets and budget 16 bills for each agency and branch of state government to the 17 proper committees with instructions to effect a reduction in 18 funding of 10% from the level of funding for the current 19 biennium authorized for that agency or branch of government;

(3) That the appropriate committees of the Senate and
the House of Representatives make all necessary amendments
to the budget bills so as not to affect either the
obligations of the state or the payment of any salaries
required to be paid by the Constitution and laws of the
state;
