4	A BILL FOR AN ACT ENTITLED: "AN ACT REVISING PROCEDURES FOR
5	APPLYING STATE PAY SCHEDULES IN THE EVENT OF A REVENUE
6	SHORTFALL; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE AND AN
7	APPLICABILITY DATE,"

9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
10	Section 1. Procedure when revenue is insufficient. (1)
11	In the event that revenue is expected to be insufficient to
12	fulfill the appropriation for the pay schedules provided in
13	2-18-311 through 2-18-315 for the subsequent fiscal year,
14	the department shall:
15	(a) allocate the shortfall among the agencies
16	recognized in the state budget in proportion to the cost, in
17	each agency, of the pay schedule or schedules applicable to
18	that agency for the subsequent fiscal year, including the
19	step increase authorized by 2-18-303(1)(d)(iii); and
20.	(b) require each agency to reduce its expenditures for
21	personal services for the subsequent fiscal year by the
22	amount allocated to that agency under subsection (1)(a). An
23	agency may:
24	(i) maintain the pay schedule or schedules applicable

to that agency for the current fiscal year, without the step

1	increase authorized by 2-18-303(1)(d)(iii); or
2	(ii) implement either the step increase authorized in
3	2-18-303(d)(iii) or the pay schedule for the subsequent
4	fiscal year, or both, with a concomitant reduction in
5	personnel that allows the agency to achieve the required
6	reduction in expenditures for personal services.
7	(2) If an agency is required by the terms of a
8	collective bargaining agreement to implement a pay schedule
9	provided in 2-18-311 through 2-18-315 for the subsequent
10	fiscal year, the required reduction in expenditures for
11	personal services must be met through a reduction in
12	personnel, as provided in 39-31-303(3).
13	Section 2. Codification instruction. Section 1 is
14	intended to be codified as an integral part of Title 2,
15	chapter 18, part 3, and the provisions of Title 2, chapter
16	18, part 3, apply to section 1.
17	Section 3. Applicability. This act applies to fiscal
18 -	years beginning after June 30, 1985.
19	Section 4. Effective date. This act is effective on
20	passage and approval.
