In compliance with a written request, there is hereby submitted a Fiscal Note for <u>SB001</u>, Version: as introduced.

Description of Proposed Legislation:

Senate Bill 001 of the third special session amends section 7-32-2123, MCA to allow County Sheriffs who operate a jail to appoint nonsworn individuals as jailers and provides that these nonsworn jailers need not receive the same salary as Deputy Sheriffs.

Assumptions:

- 1) Salaries of deputy sheriffs and jailers will remain at fiscal 86 levels throughout fiscal 1987.
- 2) Most sheriff's departments are paying non-deputy jailers less than deputies at the present time.
- 3) Salary figures for deputy sheriffs do not include negotiated pay increases nor longevity payouts.
- 4) Employer benefits are 20% of base salary.
- 5) First, second and third class counties will appoint two jailers; county classes 4-7 will have one jailer.

Long-Range Effects of Proposed Legislation:
