4 A BILL FOR AN ACT ENTITLED: "AN ACT TO SUBMIT TO THE  
 5 QUALIFIED ELECTORS OF MONTANA AN AMENDMENT TO THE MONTANA  
 6 CONSTITUTION TO REPEAL ARTICLE XI, SECTION 9, OF THE  
 7 CONSTITUTION OF MONTANA THAT REQUIRES AN ELECTION ON WHETHER  
 8 TO CONDUCT A VOTER REVIEW OF LOCAL GOVERNMENT EVERY 10 YEARS  
 9 AND CONTAINS OTHER MATTERS PERTAINING TO VOTER REVIEW OF  
 10 LOCAL GOVERNMENT."

 12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:  
 13 Section 1. Repealer. Article XI, section 9, of The  
 14 Constitution of the State of Montana is repealed.

15 Section 2. Submission to electorate. This amendment  
 16 shall be submitted to the electors of Montana at the general  
 17 election to be held November 8, 1988, by printing on the  
 18 ballot the full title of this act and the following:

- 19  FOR abolishing the voter review of local government
- 20 process set forth in the Montana Constitution.
- 21  AGAINST abolishing the voter review of local
- 22 government process set forth in the Montana
- 23 Constitution.
