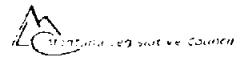

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:  
Section 1. Repealer. Section 19-5-504, MCA, is  
repealed.  
Section 2. Applicability. This act applies  
retroactively, within the meaning of 1-2-109, to membership  
in the judges' retirement system on or after January 1,  
1987.  
Section 3. Effective date. This act is effective on  
passage and approval.
