DESCRIPTION OF PROPOSED LEGISLATION:

An act to increase the penalty for violation of the fuel conservation speed limit from \$5 to \$20.

ASSUMPTIONS:

- 1. 75,800 55 mph violations were written in 1986. It is assumed that 20% fewer violations will occur in FY88 and FY89 due to driver regard for the increased fee.
- 2. It is assumed that the court cost will be \$7.50 as set by Section 3-10-603, MCA.
- 3. Balance of the fines not distributed will go into the state's general fund.
