8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

9 Section 1. Educational service cooperatives. (1) For 10 the purpose of providing comprehensive and efficient 11 educational services to Montana school children, the 12 superintendent of public instruction shall divide the state 13 into no more than 20 educational service cooperatives.

14 (2) An educational service cooperative shall provide
15 special education and related services for all member
16 districts in the cooperative. A cooperative may provide
17 other educational services and programs allowed in Title 20,
18 including but not limited to gifted and talented programs,
19 school transportation, and traffic education.

20 (3) A cooperative may be established under the
21 provisions of 7-11-101 through 7-11-108, relating to
22 interlocal agreements.

23 (4) The superintendent of public instruction shall
24 adopt rules to implement educational service cooperatives.
25 The rules must be based on the following criteria:



1 (a) An educational service cooperative shall service a geographic area encompassing a minimum school enrollment of 2 3,000 pupils based on average number belonging. 3 The superintendent of public instruction may make exceptions to A this enrollment requirement only for compelling reasons of 5 б population density, geographic factors, or unique local 7 conditions but shall make any exception in compliance with 8 the provision in subsection (1) that limits to 20 the number 9 of cooperatives that may be established in the state.

10 (b) Membership in an educational service cooperative
11 is mandatory for receipt of special education funding under
12 Title 20, chapter 9, except for a district that has at least
13 3,000 pupils.

(c) If a district is required to participate in an 14 15 educational service cooperative under subsection (4)(b), all administrative, clerical, and related-services personnel for 16 district special education programs must be budgeted with 17 the educational service cooperative. Each special education 18 19 program or specialist in a district that has a case load 20 with at least the number of pupils per teacher as provided 21 in the special education rules of the superintendent of public instruction may budget with the district to receive 22 23 funding for such instructional personnel and specialists.

24 (5) School programs other than special education25 programs that are included in an educational service

7 Section 2. Powers and duties of educational service

8 cooperative. (1) An educational service cooperative:

9 (a) must be a legal entity;

10 (b) shall have the powers, duties, and 11 responsibilities granted school districts in Title 20 and 12 other Montana law, except that an educational service 13 cooperative may not have the authority to request a property 14 tax levy for cooperative funding purposes;

15 (c) must be accredited by the board of public 16 education as provided in 20-7-101 in order to receive state 17 funding; and

18 (d) shall have as a director a person who is certified
19 and endorsed as a special education administrator according
20 to the teacher certification rules of the superintendent of
21 public instruction.

22 (2) An educational service cooperative may:

(a) establish a cash reserve fund of 15%, in the
 manner provided in 20-9-104; and

3 Section 3. Contents of a cooperative contract. The 4 contract of an educational service cooperative authorized in 5 [section 1] may include all necessary and proper matters but 6 must specify the following:

7 (1) the purpose, organization, composition, and8 service delivery system of the cooperative;

9 (2) the manner of:

10 (a) financing the cooperative and its services; and

11 (b) establishing and maintaining a budget for the
12 financing;

13 (3) the manner of acquiring, holding, and disposing of14 real and personal property used by the cooperative;

15 (4) provision for an administrator or a joint board 16 responsible for administration of the cooperative, including 17 representation of the contracting districts on the joint 18 board; and

19 (5) any other necessary and proper matters.

20 Section 4. Codification instruction. Sections 1 21 through 3 are intended to be codified as an integral part of 22 Title 20, chapter 7, part 4, and the provisions of Title 20

23 apply to sections 1 through 3.

24 Section 5. Repealer. Sections 20-7-451 through

25 20-7-455, MCA, are repealed.
