A BILL FOR AN ACT, ENTITLED: "AN ACT PROVIDING A COST-OF-LIVING INCREASE IN SERVICE AND DISABILITY RETIREMENT ALLOWANCES AND SURVIVORSHIP ALLOWANCES FOR CERTAIN RETIRED MEMBERS OF THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM OR THEIR BENEFICIARIES; AND PROVIDING AN EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Cost-of-living increase. Effective July 1, 1987, a member of the retirement system retired before July 1, 1986, or his beneficiary is entitled to receive a 5.5% increase in his monthly service or disability retirement allowance or survivorship allowance.

Section 2. Extension of authority. Any existing authority of the public employees' retirement board to make rules on the subject of the provisions of this act is extended to the provisions of this act.

Section 3. Codification instruction. Section 1 is intended to be codified as an integral part of Title 19, chapter 3, and the provisions of Title 19, chapter 3, apply to section 1.

Section 4. Effective date. This act is effective July 1, 1987.
