9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10 Section 1. Motor vehicle liability -- driving records
11 of governmental insureds. The rates and other insurance
12 matters relating to motor vehicle liability insurance for a
13 governmental entity, including cities, towns, counties, and
14 school districts, may be based only on the driving records
15 of the entity's officers and employees during their course
16 of employment by the entity. Any matter involving the
17 operation of a motor vehicle by such officers and employees
18 while not in the course of employment by the governmental
19 entity is not applicable to the motor vehicle liability
20 insurance of the governmental entity.

21 Section 2. Extension of authority. Any existing
22 authority of the commissioner of insurance to make rules on
23 the subject of the provisions of this act is extended to the
24 provisions of this act.

25 Section 3. Codification instruction. Section 1 is

1 intended to be codified as an integral part of Title 33, and
2 the provisions of Title 33 apply to section 1.
