DESCRIPTION OF PROPOSED LEGISLATION:

HB307 would provide for the nomination or election of outfitters to the Board of Outfitters and Montana Outfitters' Council to be by notarized mail-in ballot rather than by attendance at a meeting and eliminate the annual meeting for nomination and election.

ASSUMPTIONS:

- 1. There will be an annual mailing of 300 ballots.
- 2. Administrative rules will be required each fiscal year.
- 3. A small amount of clerical time will be spent in mailing and tracking ballots.
