STATE OF MONTANA - FISCAL NOTE

In compliance with a written request, there is hereby submitted a Fiscal Note for HB370, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

An Act increasing the amount authorized for meal reimbursement for state employees and certain officials engaged in state business while away from their designated headquarters but within the state; and amending Section 2-18-501, MCA.

ASSUMPTIONS:

1. The amount of in-state meals (object 2407) and in-state meals overnight (object 2410) for elected officials, appointed members of boards, commissions, councils, department directors, and all other state employees will equal FY88 actual for each year of the biennium.
2. The University System in-state meal costs will not be included in the projections.
3. The bill provides for an increase in the daily allowance for in-state meal costs from \$14.50 to \$17; \$4 for morning meal, \$4 for the midday meal, and \$9 for evening meal.
4. No additional appropriation authority is being requested. Agencies will absorb the costs within current level budgets.



authorized the actual cost of lodging, not exceeding \$24 per day, and taxes on the allowable cost of lodging, except as provided in subsection (3), plus \$3 \$4 for the morning meal, \$3.50 \$4 \$4.50 \$3.50 \$4.50 for the midday meal, and \$8 \$9 \$8.50 \$9 for the evening meal. All claims for lodging expense reimbursement allowed under this section must be documented by an appropriate receipt.

(2) For travel out of the state of Montana, the following provisions apply:

(a) The governor shall--be is authorized the actual cost of lodging in addition to a meal allowance not to exceed \$30 per day.

(b) All other elected state officials, appointed members of boards, commissions, councils, department directors, and all other state employees shall--be are authorized the actual cost of lodging not exceeding \$50 per day, except as provided in subsection (3), plus \$4 for the morning meal, \$6.50 for the midday meal, and \$12 for the evening meal. All claims for the lodging expense reimbursement allowed under this subsection must be documented by an appropriate receipt.

(3) All other elected state officials, appointed members of boards, commissioners, councils, department directors, and all other state employees shall--be are authorized the actual cost of lodging when traveling in the



1 normal course of their duties to certain designated areas.
 2 The department of administration shall designate those areas
 3 where the actual cost of lodging ~~shall~~ may be reimbursed.

4 (4) When other than commercial, nonreceiptable lodging
 5 facilities are utilized by a state employee while conducting
 6 official state business in a travel status, the amount of \$7
 7 ~~will--be~~ is authorized for lodging expenses for each day in
 8 which travel involves an overnight stay in lieu of the

Dear Representative Vincent and Senator Galt:

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby veto the adoption of House Bill 370, "AN ACT INCREASING THE AMOUNT AUTHORIZED FOR MEAL REIMBURSEMENT FOR STATE EMPLOYEES AND CERTAIN OFFICIALS ENGAGED IN STATE BUSINESS WHILE AWAY FROM THEIR DESIGNATED HEADQUARTERS BUT WITHIN THE STATE; AND AMENDING SECTION 2-18-501, MCA." for the following reasons.

House Bill 370 increases meal reimbursements for in-state meals for State employees, elected officials and members of boards, commissions, etc. The projected fiscal impact of additional spending increases the cost to State government by approximately \$300,000 each year of the coming biennium.

I do not exercise this veto lightly and realize that costs of meals for employees require consideration. However, the present fiscal condition of our state and my responsibilities to contain the growth of government spending requires that I must veto legislation that does not demonstrate a compelling state or public policy interest for additional costs.
