DESCRIPTION OF PROPOSED LEGISLATION:

A bill for an Act entitled: "An Act creating a genetic engineering technology research and development account for certain funds appropriated or contributed to Montana State University; and appropriating money to Montana State University to provide additional support for applied genetic engineering technology research and development to enhance Montana agricultural products."

ASSUMPTIONS:

1. A designated subfund for "Genetic Engineering Technology Research and Development Account" is established.
2. General appropriation authority for \$160,000 to current fund restricted for the bill's purpose is made.
3. \$80,000 for this account is appropriated each year of the biennium.
