DESCRIPTION OF PROPOSED LEGISLATION:

An Act clarifying the Department of Administration's responsibility regarding state buildings in the state capitol area; and amending Section 2-17-111, MCA.

ASSUMPTIONS:

1. The department will assess and approve all custodial, maintenance and security work done on state owned or leased buildings within the state capitol area.
2. The department will review and approve all alterations, improvements, repairs and remodeling for state buildings in the state capitol area.
3. An additional FTE (architect/engineer) will be needed.
