

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 7-13-232, MCA, is amended to read:

"7-13-232. Determination of service charge. (1) The Except as provided in subsection (2), THE fees shall be based upon a family residential unit, and fees for commercial and industrial accounts shall be based on the comparison with a typical residential unit as to volume and type of waste produced.

(2) In a mobile home park, the fee shall be based upon each occupied mobile home space and shall be paid by the individual lessee of the space. FEES FOR MOBILE HOME PARK ACCOUNTS SHALL MUST BE BASED UPON THE NUMBER OF MOBILE HOME

SPACES OCCUPIED ON JANUARY 1 PAID BY THE REGISTERED OWNER OF EACH MOBILE HOME IN THE MOBILE HOME PARK.

(2)(3) In no case shall the fee for disposal service exceed one-half the total fee for both collection and disposal services."
