DESCRIPTION OF PROPOSED LEGISLATION:


An act increasing the fee charged by a county treasurer for making and acknowledging a deed for property sold for delinquent taxes; providing an effective date of July 1, 1989.


FISCAL IMPACT:

This proposal has no impact on department revenues or expenditures.

EFFECT ON COUNTY OR OTHER LOCAL REVENUE OR EXPENDITURES:

Currently there are two statutes dealing with tax deed fees; 15-18-211, MCA, and the one being amended by this proposal; 7-6-2131, MCA. A survey of counties indicate that many are now charging the \$25 mentioned in 15-18-211. Therefore, the impact on local governments would be minimal.
