ASSUMPTIONS:

- 1. Approximately 5,594 certificates will be issued in FY90, as well as FY91, the same as issued in FY88.
- 2. OPI will not receive any revenues from the increase in fees; the \$1 increase will be remitted to the Board of Education for the Certification Standards and Practices Advisory Council.
