*19-7-501. Eligibility and application for service retirement — commencement of allowance. (1) (a) A member initially elected or appointed before July 1, 1989, who has completed at least 24 years of service may retire on a service retirement allowance.

(b) A sheriff-in-service member initially elected or appointed on or after July 1, 1989, who has completed at least 25 24 years of service and who has reached the age of 55 50 years may retire on a service retirement allowance.

In compliance with a written request, there is hereby submitted a Fiscal Note for SB194, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

An act revising eligibility requirements for service and early retirement under the sheriff's retirement system; amending Sections 19-7-501 and 19-7-502, MCA; and providing an effective date.

ASSUMPTIONS:

- 1. Based upon the 1988 valuation performed on the Sheriffs' Retirement System, a contribution rate equal to 1.92% of active members' salaries would be sufficient to pay for benefits as they accrue in the future.
- 2. The current statutorily required contribution rate into the Sheriffs' Retirement System is 14.67% (composed of a 7.0% from employees and 7.67% from employers. While the 1988 actuarial valuation only requires a 12.754% contribution rate to fund the normal costs of the system (there is currently no unfunded liability for this system), an additional contribution of .004% of salaries would be required to fund the costs of the proposed benefit enhancement; however, no change in the statutory funding rate is proposed at this time.
- 3. An additional 17 members could retire during FY90 with an increased retirement benefit as a result of this bill. If it is assumed that all of those additionally eligible will actually retire during the next biennium because of this bill, and assuming half retire during each year of the next biennium, 9 additional members will retire with unreduced benefits during FY90 and 8 additional members will retire during FY91. Because the costs of these enhancements are covered by the current statutory contribution rate, the additional costs associated with these retirements have not been estimated.
- 4. There may be savings appreciated with members retiring earlier and having their positions refilled by persons with less seniority which may or may not be offset by any lump-sum vacation and/or sick leave payouts due the retiring members. Since no data is available to calculate any savings/(cost), this has not been attempted.
- 5. Salaries for current members of the Sheriffs' Retirement System for the next biennium are based on the October 1988 payrolls submitted to the Sheriffs' Retirement System and are assumed to increase 2% each year of the next biennium. If salary increases are more than 2%, the costs will increase; if salary increases are less than 2%, costs will decrease.

LONG-RANGE EFFECTS OF PROPOSED LEGISLATION:

This legislation will provide increased retirement benefits to members of the Sheriff's Retirement System and will reduce the age and service requirements for regular and early retirements.

TECHNICAL OR MECHANICAL DEFECTS OR CONFLICTS WITH EXISTING LEGISLATION:

The bill proposes to amend 19-7-501, MCA, which is also proposed to be amended by HB089 (which has currently passed the House and has been transmitted to the Senate). If both bills pass, the two must be coordinated in order to assure amendments to this part of the law are consistent.
