# STATE OF MONTANA - FISCAL NOTE

In compliance with a written request, there is hereby submitted a Fiscal Note for SB233, as introduced.

## DESCRIPTION OF PROPOSED LEGISLATION:

SB233 would authorize parimutuel betting on mule races and provide for regulation of mule races by the Board of Horseracing.

## ASSUMPTIONS:

- 1. Because mule races will run in conjunction with existing races of Quarter horses and other breeds, the expenditures of the Board of Horseracing will remain at current level.
- 2. The board's share of the parimutuel handle is 1%.
- 3. Assume 20 mule races per year at an average handle of \$7,000 per race for a total of \$140,000 per year.
- 4. Assume 50 additional people with a \$20 licensing fee will generate \$1,000 additional licensing fees revenue for the board.

If the report shows the underpayments to be 4 5 in excess of the overpayments, the balance shall be paid to the department. Money paid to the department may be used for 6 7 the expenses incurred in carrying out this chapter. The 8 licensee shall, at the same time, pay to the department all 9 sums collected under 23-4-202(4)(d) on exotic wagering on 10 races.

(2) At the end of the racing season, sums collected 11 under 23-4-202(4)(d) must be distributed by the department, 12 13 after first passing through the board's agency fund account, to the licensed owners of those Montana-bred horses or mules 14 finishing in the money at the meet from which the sums 15 16 derived. The owner's award must be calculated as follows: 17 (a) divide the total amount collected under 23-4-202(4)(d) by the total amount won by Montana-bred 18 horses or mules; 19
