(1) The following persons who apply for a Class A-3 or a Class A-4 license may receive 13 14 certification by the department for a license that allows 15 another person with the same class of license to shoot and 16 kill for the certified person any game permitted by the 17 certified person's license:

18 (a) a resident who is 65 years of age or older; or

19 (b) a disabled resident who is certified as disabled20 as prescribed by department rule.

(2) For a resident 65 years of age or older, the
certification authorized in subsection (1) must be attached
to the applicable license purchased under 87-2-801.

24 (3) For a disabled resident, the certification must be
25 attached to the permit required under 87-2-803.



(4) The certification must include the name of the
 person or persons designated to make the kill of any game
 permitted by the license.
