SB325 is an Act to allow members of the Montana Arts Council to receive compensation for services and travel expenses; and amending Sections 22-2-102 and 22-2-103, MCA.

The Council has 15 members and meets four times per year. Each meeting lasts 2 days. The daily rate is \$50 per day as provided in 2-15-204, MCA.


