Section 61-3-313, MCA, is amended to read: 10 "61-3-313. Vehicles subject to staggered registration. 11 For purposes of 61-3-313 through 61-3-316 "vehicle" means 12 any motor vehicle as defined in 61-1-102 subject to annual 13 registration in this state except: 14 (1) vehicles owned or leased and operated by the 15 government of the United States, of the state of Montana, or 16 its political subdivisions; 17 (2) mobile homes and-motor-homes; 18 (3) vehicles that are registered in accordance with or 19 subject to 61-3-411, 61-3-421, or 61-3-451; 20 (4) trucks exceeding a licensed gross vehicle weight 21 of 10,000 pounds; 22 semitrailers, tractors, buses, (5) trailers, 23 motorcycles, guadricycles, and motor-driven cycles; 24 (6) special mobile equipment as defined in 61-1-104." 25

1 NEW SECTION. Section 2. Transitional and new 2 registrations. Each motor home currently registered in Montana and subject to the provisions of [this act] must be 3 4 reregistered under the provisions of [this act] and must be assigned a registration period under 61-3-314 that 5 corresponds to the last digit on the license plate issued to 6 7 that motor home in 1989. Motor homes that are registered 8 for the first time in Montana must be assigned a registration period corresponding to the month when they are 9 first registered in this state. The registration period 10 thereafter remains the same from year to year. 11

12 <u>NEW SECTION.</u> Section 3. Applicability. [This act]
13 applies to registrations of motor homes occurring after
14 December 31, 1989.

15 <u>NEW SECTION.</u> Section 4. Extension of authority. Any 16 existing authority to make rules on the subject of the 17 provisions of [this act] is extended to the provisions of 18 [this act].
