SENATE RESOLUTION NO. 3

INTRODUCED BY THE SENATE STATE ADMINISTRATION COMMITTEE

A RESOLUTION OF THE SENATE OF THE 51ST LEGISLATURE OF THE STATE OF MONTANA CONCURRING IN, CONFIRMING AND CONSENTING TO THE NOMINATIONS AND APPOINTMENTS MADE BY THE GOVERNOR AND SUBMITTED BY WRITTEN COMMUNICATIONS DATED JANUARY 30TH AND FEBRUARY 2ND, 1989, TO THE SENATE PURSUANT TO 5-5-302, MCA.

(4) As director of the Department of Family Services in accordance with Section 2-15-111 and 2-15-2401, MCA.

Mr. Robert L. Mullen, Sidney, Montana 59270, appointed to serve a term at the pleasure of the Governor.

(5) As Commissioner of the Department of State Lands in accordance with Section 2-15-111, and 2-15-3202, MCA.

Mr. Dennis D. Casey, Shawnee, Kansas 66216, appointed to serve at the pleasure of the Governor.

(6) As member of the Board of Natural Resources and Conservation in accordance with Section 2-15- 3302, and 2-15-124, MCA.

Mr. Ed McHatton, Lolo, Montana 59847, appointed to serve until January 2, 1993.
