

STATE OF MONTANA - FISCAL NOTE

In compliance with a written request, there is hereby submitted a Fiscal Note for SB0098, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

An act revising laws regarding the labeling and sale of agricultural seed; revising seed dealer license provisions, penalties, and fees; and creating a seed account in the state special revenue fund for deposit of seed fee revenue.

ASSUMPTIONS:

- 1. Seed program will become self-supporting.
- 2. Seed license fee projections are based on FY92 actual experience.
- 3. Seed program funding will be converted from general fund to a state special revenue account effective July 1, 1993.
- 4. Approximately 10% of total program general fund expenditures occur in the seed program (based on historical employee time and expense data). FY94 and FY95 expenditures are based on executive budget data which includes an indirect charge for services provided by the Department of Agriculture. Indirect costs are calculated using 18.28% of personnel services in FY94 and 18.31% in FY95.
- 5. Each type of seed license (dealer, labeler and conditioner) will increase to \$100 each, to be established by rule.
- 6. The net general fund impact is \$48,558 in FY94 and \$47,293 in FY95 because the current law fees of \$13,430 per annum are deposited to the general fund.
