4 A BILL FOR AN ACT ENTITLED: "AN ACT MAKING IT A JUVENILE
5 OFFENSE FOR A STUDENT TO CARRY OR STORE A WEAPON AT SCHOOL
6 AND A CRIMINAL OFFENSE FOR AN ADULT TO CARRY OR STORE A
7 WEAPON AT SCHOOL OR FOR A PARENT OR GUARDIAN TO ALLOW A
8 STUDENT TO CARRY OR STORE A WEAPON AT A SCHOOL."

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11 NEW SECTION. Section 1. Possession or allowing
12 possession of a weapon at school -- exceptions -- penalties.

13 (1) A person commits the offense of possession of a weapon
14 at school if the person purposely or knowingly carries or
15 stores in a school or on the school grounds without the
16 consent of the school administration a firearm; knife or
17 dagger with a blade 4 or more inches long; sword; straight
18 razor; throwing star; nun-chucks; brass or other metal
19 knuckles; or slingshot.

20 (2) A parent, guardian, or other person having custody
21 of a student commits the offense of allowing possession of a
22 weapon at school if the person purposely, knowingly, or
23 negligently allows the student to carry or store in a school
24 or on the school grounds without the consent of the school
25 administration a firearm; knife or dagger with a blade 4 or

1 more inches long; sword; straight razor; throwing star;
2 nun-chucks; brass or other metal knuckles; or slingshot.

3 (3) (a) This section does not apply to law enforcement
4 personnel.

5 (b) A school may give persons and entities advance
6 permission to carry or store weapons.

7 (4) (a) An adult convicted under this section shall be
8 imprisoned in the county jail for a term not to exceed 6
9 months, fined an amount not to exceed \$500, or both.

10 (b) Action against a person under 18 years of age must
11 be under the Montana Youth Court Act.

12 NEW SECTION. Section 2. Codification instruction.

13 [Section 1] is intended to be codified as an integral part
14 of Title 45, chapter 8, part 3, and the provisions of Title
15 45 apply to [section 1].

DESCRIPTION OF PROPOSED LEGISLATION:


Creates a juvenile offense for a student to carry or store a weapon at school and a criminal offense for an adult to carry or store a weapon at school or for a parent or guardian to allow a student to carry or store a weapon at school.

ASSUMPTIONS:


1. Based on 1991 Montana Uniform Crime Reporting (MUCR) data, the following statistics are assumed to be representative of the average number of relevant complaints/arrests:
 - (a) 410 total complaints statewide;
 - (b) Eight complaints at schools/colleges resulting in four arrests;
 - (c) 71 Juveniles were arrested on weapons charges, premises unknown;
 - (d) 108 adults were arrested on weapons charges, premises unknown.
2. Given the data in assumption 1, it is assumed that the bill will have no material fiscal impact.
