(8) establish by rule an integrated pest management program, complete with field scouting services, as provided in--80-11-411. The purpose of the program is to identify, as early as possible, any potentially damaging diseases, weeds, or pests that could inhibit the long-term health of the

In compliance with a written request, there is hereby submitted a Fiscal Note for HB0163, as introduced.DESCRIPTION OF PROPOSED LEGISLATION:

An act allowing the Montana Mint Committee to establish an integrated pest management program by rule rather than by statute; reducing the minimum mint oil assessment.

ASSUMPTIONS:

1. Revenue estimates are based on projected mint oil production in FY94 at 300,000 lbs. and at 360,000 lbs. in FY95.
2. Mint oil assessment will decrease from \$0.10 to \$0.08 per pound.
3. FY94 and FY95 expenditures are based on executive budget data.
4. IPM field scouting program will become optional rather than mandatory. Contracted services expenditures will reduce correspondingly to the revenue reductions.
