In compliance with a written request, there is hereby submitted a Fiscal Note for HB0366, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION: An act repealing the surcharge on retail sale of field rodenticides; amending and repealing existing statutes and providing an immediate effective date.

ASSUMPTIONS:

1. \$2,000 in the rodenticide account will be carried over and will expended in FY94. There will be no carry-over in FY95.
2. Department of Agriculture will receive up to \$5,000 in grant funds from rodenticide companies to conduct special field studies or research on control of field rodents with their rodenticide in FY95.
3. Current expenditure data is based on FY93 appropriated level.
