STATE OF MONTANA - FISCAL NOTE

In compliance with a written request, there is hereby submitted a Fiscal Note for HB0393, as introduced.

<u>DESCRIPTION OF PROPOSED LEGISLATION</u>: This bill would combine the currently authorized brush disposal and timber stand improvement fees and associated accounts into a single fee and account for forest improvement. It would also authorize the Department of State Lands to spend forest improvement funds on road maintenance and acquisition, and other legal requirements associated with timber harvesting.

ASSUMPTIONS:

- 1. The amount of the forest improvement fee would, at least initially, be identical to the sum of the current brush disposal and timber stand improvement fees. This combination of fees would apply to all active timber sales on the effective date, as well as all timber sales sold after that date.
- 2. The forest improvement fee would be set by the Board of Land Commissioners, as are the current brush disposal and timber stand improvement fees.
- 3. While the bill provides for additional uses of the forest improvement account, there is no corresponding budget modification under legislative consideration to allow expenditure of additional funds for these uses. Modifying the fee level to provide revenue for these uses would require separate approval by the Board of Land Commissioners. Consequently, the bill does not involve additional expenditures or provide additional revenues.
- 4. The table shows the current total expenditures and revenues with no net impact.


