STATE OF MONTANA - FISCAL NOTE

Form BD-15

In compliance with a written request, there is hereby submitted a Fiscal Note for HB0435, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

The bill continues full participation benefits from the Volunteer Firefighters' Pension Fund at \$120/month during the next biennium while the agency continues to study the sufficiency of the fund to sustain fixed benefit payments. It also revises the eligibility requirements and procedure for applying for partial pension benefits.

ASSUMPTIONS:

- 1. Current law sets pension benefit amounts for FY92 and FY93 and is silent with respect to subsequent years. Therefore, the current law column below reflects the termination of pension benefit payments. However, benefits for deaths, some disabilities, and for insurance payments would continue to be paid.
- 2. The proposed law would reauthorize pension benefits at the current full participation rate of \$120/month.
- 3. The proposed law would also reauthorize partial pension benefits and eliminates the involuntary termination of service requirement. It is assumed that no additional individuals would become eligible for partial pension benefits due to this change in eligibility requirements.
- 4. The average new retiree has 17 years of service and would be eligible for a 85% participation benefit of \$102/month.

 The number of retirees will increase by 6% per year.
- 5. Pension benefit adjustments funded by the general fund are 2.5% of total benefits paid during the preceding calendar year. 2.5% of the previous calendar year benefits will be paid into the pension trust fund and then paid out to retirees as increased benefits on March 31 of each year.
- 6. This bill does not impact payments from the Insurance Premium Tax Fund to the Volunteer Firefighters' Pension Trust Fund.

FISCAL IMPACT:

The fiscal impact shown below is relative to current law which allows pension benefits to sunset in the 1995 biennium.

HB0435 would reauthorize pension benefits in the 1995 biennium consistent with amounts being paid in the current biennium.


