STATE OF MONTANA - FISCAL NOTE Form BD-15

In compliance with a written request, there is hereby submitted a Fiscal Note for HB0677, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION: An act transferring money from the state traffic education account to be used for vocational education and gifted and talented programs.

ASSUMPTIONS:

- 1. Revenues into the traffic education account are projected to total \$1,720,200 in FY94 and \$1,677,561 in FY95.
- 2. Local school districts will receive reimbursements of approximately \$140 per pupil for high school drivers education programs in FY93 and were projected to receive \$136 per pupil in FY94 and \$128 per pupil in FY95, based on 10,061 students participating in school year 1991-1992, 10,200 participants in 1992-1993, 10,500 participants in 1993-1994 and 10,700 participants in year 1994-1995.
- 3. Current law in the table reflects the Education Committee action.
- 4. The proposed law in the table below reflects legislative action through the House Appropriations Committee. After subtracting OPI administrative costs, there will be \$1,386,280 in FY94 and \$1,339,000 in FY95 available for Traffic Education, Gifted and Talented and Secondary Vocational Education. The net available funds for traffic education will be \$586,280 in FY94 and \$539,000 in FY95.
- 5. The Gifted and Talented program would be funded at \$150,000 each year and Vocational education would be funded at \$650,000 each year of the 1995 biennium.
- 6. The practice of accruing prior year expenses and paying in the next fiscal year has been changed to reflect and pay current year expenses in the year in which the expense occurred.
