MCA: AND PROVIDING AN IMMEDIATE 9 EFFECTIVE DATE." 10 11 WHEREAS, the early migration of game animals from nearby 12 areas due to hunting pressure has caused excessive grazing of the limited winter forage in the area of the Sun River 13 14 Game Preserve; and

15 WHEREAS, prevention of excessive grazing can best be 16 accomplished by removing the game preserve designation of 17 the area and managing the area in a manner similar to nearby 18 game management areas, which management may include the 19 hunting of excess game animals in accordance with standard 20 game management practices.

17 (2) The hunting, pursuing, capturing, killing, or taking of any fish, game animals, game birds, or fur-bearing 18 19 animals in violation of the rules, regulations, or orders of 20 the department governing any closed season, fish and game 21 district, refuge, sanctuary, preserve, rest ground, or 22 closed land or water area promulgated by said the department 23 shall-be is punishable with-the-same-penalties as provided for the violation of the state fish and game laws of-this 24 25 state regarding closed seasons.
