In compliance with a written request, there is hereby submitted a Fiscal Note for SB0075, third reading.

DESCRIPTION OF PROPOSED LEGISLATION:

An act removing the termination of the change of the school district accumulated sick leave reserve fund to the compensated absence liability fund and the inclusion in the fund of accumulated amounts of sick leave and vacation leave for nonteaching and administrative school district employees.

ASSUMPTIONS :

- 1. The general fund transfers to the compensated absences liability fund at each year-end will be the same as FY92.
- 2. Any increase in the transfers between FY91 and FY92 were attributable to the inclusion of vacation leave amounts in the purpose of the fund.
- 3. The sick leave and vacation leave obligations each year-end will be the same as FY92.
- 4. If transfers for vacation leave obligations were not allowed, an equivalent amount would be reappropriated to lower general fund permissive levies in the next year.
- 5. The same districts will be eligible for GTB each year as were eligible in FY92.

FISCAL IMPACT:

Expenditures from the state equalization aid account will decrease between \$0 and \$119,416 per year, depending on whether monies not transferred to the compensated absences liability fund are spent elsewhere or reappropriated to reduce the permissive levy requirement.
