

# STATE OF MONTANA - FISCAL NOTE Form BD-15

In compliance with a written request, there is hereby submitted a Fiscal Note for SB0103, as introduced.

#### DESCRIPTION OF PROPOSED LEGISLATION:

This bill would decrease the amount that municipalities are required to pay injured police officers from the difference between gross salary and the amount of workers' compensation benefits to the difference between net salary and the amount of workers' compensation benefits.

## FISCAL IMPACT:

No fiscal impact on state government.

## EFFECT ON COUNTY OR OTHER LOCAL REVENUES OR EXPENDITURES:

The bill would reduce supplemental salary payments by local governments. The difference between gross and net salaries for affected individuals is estimated to be 15% - 20%. Within the time frame required to complete this fiscal note, data is unavailable on the number of workers' compensation awards made to injured police officers in first and second class cities. Therefore, no specific estimate of savings is available at this time.
