INTRODUCED BY NATHAN

A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING THAT WORKERS' COMPENSATION INSURANCE PREMIUMS FOR VOLUNTEER FIREFIGHTERS BE BASED ON THE NUMBER OF RUNS MADE BY THE FIRE COMPANY DURING THE PREVIOUS YEAR."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

NEW SECTION. Section 1. Premium rates for volunteer firefighters. Workers' compensation rates for volunteer firefighters, as defined in 39-71-118, who are not covered by a self-insurer, must be determined by the number of runs made in the previous year by the fire company of which the firefighter is a member.

NEW SECTION. Section 2. Codification instruction. [Section 1] is intended to be codified as an integral part of Title 39, chapter 71, part 3, and the provisions of Title 39, chapter 71, part 3, apply to [section 1].
