WHEREAS, because the United States, the birthplace of democracy, has the moral duty and the diplomatic resources

(3) That, among the alternative actions, an international peace conference including all parties to the conflict should be the centerpiece of efforts promoted by the United States.

(4) That a delegation of American-born persons of Slavic and Muslim descent should be selected to help mediate the conflict.

(5) That the efforts should be carried forward in an open attitude of fairness to all parties with no prejudice
