

In compliance with a written request, there is hereby submitted a Fiscal Note for HB0046, as introduced.

DESCRIPTION OF PROPOSED LEGISLATION:

An act allowing members of the Game Warden's Retirement System with at least 10 years of membership service to purchase additional service which can be used only for calculating the member's retirement benefit. By paying the full actuarial cost, eligible members can purchase one additional year for each 5 years of membership service, up to a maximum combined total of 5 years of additional, military, full-time public service, and U.S. Government service.

ASSUMPTIONS:

- 1. Members will pay the full actuarial cost for purchasing each year of additional service. No employer or other sources of funding will be used to pay for these benefits.
- 2. No members may retire earlier because of this legislation.

FISCAL IMPACT:

Expenditures for pension benefits would increase to the extent that members elect to purchase additional service credits. Insofar as members will pay the full actuarial cost of the additional service credits, there will be no net impact to the pension trust fund.
