STATE OF MONTANA - FISCAL NOTE

Fiscal Note for HB0102, as introduced

DESCRIPTION OF PROPOSED LEGISLATION:


An act providing that the payment of a uniform allowance to officers of the Montana National Guard is discretionary and eliminating the requirement that officers provide their own uniforms and equipment.


ASSUMPTIONS:

1. Currently, officers of the Montana National Guard supply their own uniforms. This practice will continue if HB102 passes.
2. If funds are available, an allowance for uniforms may be paid to each properly uniformed officer of the Montana National Guard.
3. The current payment level of \$5 will continue under the proposed Executive Budget.
4. The number of officers for the Army and Air Guard will be approximately the same as the number in FY94 which was 527.

FISCAL IMPACT:

Passage of HB102 will have no fiscal impact on state government.
