BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 69-3-203, MCA, is amended to read:

"69-3-203. Annual report to commission. (1) The accounts of all public utilities shall must be closed annually on either June 30 or December 31; a A balance sheet must be taken promptly therefrom, from the accounts, and a full annual reports report of the business of such the utility must be made to the commission; not later than the first following September 15 if such the accounts are closed on June 30 and not later than March 15 April 30 of the first following year when such if the accounts are closed on December 31.

(2) The reports shall must be in such the form as prescribed by the commission and shall must contain all the information deemed by that the commission considers necessary for the proper performance of its duties. The commission may at any time call for desired request information omitted from such the reports or not provided for therein in the reports whenever, in the judgment of the commission, such the information is necessary."

NEW SECTION. Section 2. Effective date. [This act] is effective on passage and approval.
