The legislature finds that: 10 (1) many people of different cultures in this state are confronted by problems such as 11 12 unemployment, underemployment, and the lack of economic and educational opportunity; 13 (2) the problems facing people of different cultures are perpetuated because there has been no 14 concerted or faithful effort to eliminate the factors contributing to undesirable social and economic 15 conditions for people of different cultures in the state; and 16 (3) there is a need to increase the awareness of both the public sector and private sector in order 17 to address the current problems and conditions confronting people of different cultures in Montana. 18 19 NEW SECTION. Section 2. Declaration of legislative purpose. Consistent with the 20 findings stated in [section 1], the legislature declares that it is the purpose of [sections 1 through 7] to 21 assist and enable people of different cultures to take their rightful place in society. 22 23 NEW SECTION. Section 3. Definitions. For purposes of [sections 1 through 7], unless the 24 context requires otherwise, the following definitions apply: 25 (1) "Coordinator for people of different cultures" means the person appointed by the governor to 26 serve in the office of state coordinator for people of different cultures as provided in [section 5]. 27 (2) "People of different cultures" means a person of Hispanic, Black, Asian, or other minority 28 descent. 29

# Fiscal Note for HB0145, as introduced

#### DESCRIPTION OF PROPOSED LEGISLATION:

Creating the Office of State Coordinator for People of Different Cultures.

#### ASSUMPTIONS:

- 1. The bill is effective July 1, 1995.
- 2. The Coordinator for People of Different Cultures will become part of the Governor's Office.
- 3. The bill calls for the appointment of a state coordinator by the Governor who shall also set the salary. The assumption is that this position will be a full 1.00 FTE and will receive approximately the same salary as the Coordinator of Indian Affairs who is also appointed by the Governor (\$37,250 plus \$9,320 benefits= \$46,570).
- 4. The state Coordinator for People of Different Cultures will need minimal support staff for the office. It is assumed that the workload will be sufficient to require 0.50 Grade 13 FTE (\$14,523 in FY96 and \$14,573 in FY97, including benefits).
- 5. Operating expenses will be approximately the same as for the Office of the Coordinator of Indian Affairs. This amounts to about \$24,000 per year.
- 6. Start-up costs for purchase of computers, equipment and furniture will be a one-time expenditure in FY96 of \$10,000.
- 7. Expenditures will be made from the general fund.
